**Any current undergraduate or law student in a JD, LLB, or LLM program is eligible for the Massachusetts Criminal Lawyer Law School Scholarship with a preference to students who (a) are or were from the Commonwealth of Massachusetts, or (b) earned an undergraduate or graduate degree from a college or university in Massachusetts, or (c) are attending a law school in Massachusetts.**
